The supporting documents of the bidders were scrutinized by the Committee against check-list / tender conditions.

1. **M/S. ANUSHA HOSPITALITY SERVICES PRIVATE LIMITED** has submitted all the required documents. **Hence it is qualified.**
2. **M/S. FINE CATERERS AND SUPPLIERS** has submitted all the required documents. **Hence it is qualified.**
3. **M/S. FIRST MAN MANAGEMENT SERVICES PVT.LTD** has not submitted the following documents
 - a. Certificate for continuous serving of food at least 1000 people as a single Unit for at least two years of last three financial years.
 - b. Proof for minimum 60 workers/staff on the EPF and ESIC rolls of the Service Provider's organization doing job in all of its Industrial/ Institutional Mess/Mess (Latest Three months TRRN for EPF and ECR for ESIC as proof for number of workers/staff on roll)
 - c. The Bidder should have valid labor license for 60 members.

Hence it is disqualified.

4. **M/S. FOOD SUTRA HOSPITALITY SERVICES** has submitted all the required documents. **Hence it is qualified**
5. **M/S. KRISHNA FACILITY SERVICES** has not submitted the following documents
 - a. The bidder should be in catering business (excluding beverage and snacks services) for a minimum period of three years as on bid calling date to various organizations/institutions. (Copy of Experience certificate not enclosed).
 - b. The bidder should have served continuously at least 1000 people/students on a normal working day in a single unit for the last two financial years in any of the last three financial years in any entity/organization/educational Institution. (Work orders and relevant satisfactory certificates are not uploaded /submitted. Both documents mandatory).
 - c. Proof for minimum 60 workers/staff on the EPF and ESIC rolls of the Service Provider's organization doing job in all of its Industrial/ Institutional Mess/Mess (Latest Three months TRRN for EPF and ECR for ESIC not uploaded/submitted as proof for number of workers/staff on roll)
 - d. The Service provider has not submitted a valid EPF registration
 - e. Valid registration with ESIC under relevant Act is not enclosed
 - f. The Bidder has not submitted valid labor license for 60 members.
 - g. An undertaking (self-certificate) that the firm is not having any suit/criminal case pending against its proprietor or any of its employees or having been earlier convicted for violation of PF /ESI /Minimum Wages Act or any other laws in force is not submitted.

- h. Experience in serving Andhra Food at least for two years is mandatory. (Menu copy pertaining to previous work orders duly certified by the competent authority is not submitted)

Hence it is disqualified.

6. M/S. KRISHNA CONSTRUCTIONS has submitted all the documents. **Hence it is qualified**

7. M/S. MERCURY MARVEL HOSPITALITY PRIVATE LIMITED has not submitted proof for 60 members of EPF for the month of August, 2019. **Hence it is disqualified.**

8. M/S. P VENKATA SRIDHAR has submitted all the documents. **Hence it is qualified**

9. M/S. SHAKTHI KITCHEN PRIVATE LIMITED: It is found that a legal case (W.P.No 21338 of 2019) in the High Court of Telangana is pending against M/S Shakti's Kitchen Pvt Ltd, Chennai. **Hence it is disqualified.**

10. M/S. SEC SERVICES has submitted all the documents. **Hence it is qualified.**

11. M/S. SRI ADITYA HOTELS AND RESORTS has not submitted the following documents

- a. Continuous serving of food to 1000 people as a single Unit at least two years out of last three financial years.
- b. Labor license for 60 members
- c. Experience in serving Andhra food.

Hence it is disqualified.

12. M/S. SRI KAMADHENU CATERING has not submitted the following documents

- a. Continuous serving of food to 1000 people as a single Unit at least two years out of last three financial years
- b. Copies of GST Returns 2018-19
- c. Proof of Minimum 60 workers/staff on the EPF and ESIC rools
- d. Labor license for 60 members
- e. Copy of an undertaking (Self-Certificate) that the firm is not having any suit/criminal case pending against its proprietor or any of its employees or having been earlier convicted for violation of PF /ESI /Minimum Wages Act or any other laws in force.

Hence it is disqualified.
