Applications are invited for the Post of Residential Medical Officer for RGUKT-Ongole campus, Ongole District of RGUKT -A.P either on deputation/lien or on purely contractual basis for a tenure of one year and extendable subject to terms and regulations of University.

Qualifications and other details:

Candidates with MBBS (Experience/ PG Degree/ Post Graduate Diploma holders shall be preferred) from recognized university with appropriate registration as prescribed in the schedule of Medical Council of India (MCI).

The post of Residential Medical Officers on purely temporary basis on contract with consolidated salary with rent free accommodation as per Institute norms inside the campus. In cases of in-service candidates, the candidates are entitled for protection of last pay drawn. The candidates working in other organizations/ Universities intending to work on deputation should apply through proper channel with a clear no objection certificate from the employer stating that there will not be any objection to relieve the candidate at short notice in case of selection.
